**WHEREAS**, Galispi Road is a parish road running south from Miller Road for a distance of approximately 1,300 feet then turning easterly for a distance of approximately 300' into a dead-end "loop";

**WHEREAS**, the owner of the property upon which the easterly-running portion and dead-end loop of Galsipi Road are located has requested that the Ouachita Parish Police Jury revoke the public right-of-way of said portion of Galispi Road in order that he can place a gate at his property line to control trespassing and illegal dumping that is occurring; and,

**WHEREAS**, the Ouachita Parish Police Jury finds that the requested revocation will not adversely affect other properties and is in the public interest.
